The Regional Assembly is going to be held on April 13<sup>th</sup> from 10 AM to 4 PM at the KC Hall, 405 South Street in Schulenburg, Texas. All of the GSR's and GSRA's need to attend this event if possible. If you know of anyone that you would like to nominate for the RD and RDA positions, they must be present at the Regional Assembly to qualify. The qualifications for these two positions are in the Guide to Local Service. I am asking this body for \$150.00 for myself, Craig W. and a couple of GSR's in the vehicle to travel to this event. Anyone can attend this event so please get the word out to your home groups. Carpooling is suggested so we can cut down on the cost for CBANA.

- A deposit in the amount of \$315 was made on March 1<sup>st</sup>, bringing our current balance to \$3401.48.
