1. Paul's proposal that was tabled last month: Start a Banner (FLAG) wars again. Capture the flags from groups. Purchase Flag and Stand. CBANA logo and N.A symbol still in question. Tabled to bring back to groups, how many participants needed to capture flag?

Today's discussion:

- Part one of the proposal: Vote to purchase flag.
 - Paul says price is \$130. Lyman proposes NA symbol on one side, CBANA symbol on the other side. Tom M makes motion to make flag with symbols on both sides. Ryan seconds the motion. Motion passes.
- Part two of the proposal: How many participants per home group are required to capture the flag?
 - o Tom M. proposes 3 home group members, Ryan Z. seconds motion, no one opposes, motion passes.

- Capture the flag will be started.
- 2. Stephen's proposal that was tabled last month: Add a budget to activities committee and/or put a cap on monthly allowance per event. Jason B needed to do more research on needed bank information.

Today's discussion:

- Stephen proposes to strike the above proposal/statement from the April minutes altogether.
- He clarifies that the proposal that passed last month was to remove activities from the list of self-supporting subcommittees and add activities to the list of subcommittees who have a quarterly budget
- The incorrect proposal from April's minutes will be removed
- 3. Megan's proposal that was tabled last month: figure out who providers toner & paper for Area and add to policy

Today's discussion:

• Tom M. proposes that toner & paper be purchased via ASC admin budget and it is ASC admin's responsibility to make sure toner and paper are stocked. Ryan provides a print-out report from the copy machine that shows how many copies were actually made. Tom M. suggests that we wait until new business for more to be revealed regarding paper & toner.

NEW BUSINESS: While establishing quorum, it is noted that not many GSRs are present today. Paul suggests forming an ad-hoc committee for someone to reach out to groups to remind them of ASC. Megan adds that she has gathered email addresses for GSRs for each group so they can at least receive the minutes. Paul's idea for ad-hoc is moved to new business. Lidilla proposes removing groups from the meeting schedule if they don't show up to Area. Tom indicates that policy can't be changed until July. Proposal to remove groups from the schedule if they don't attend Area will be tabled until July.

Tom M. proposes to create an ad-hoc for budgets and timelines for all committees. In that budget/timeline, a spreadsheet will be created that shows when ASC pays for what and when it is paid. The objective is to find out how much each subcommittee spends on quarterly expenses so we know what to set aside every year to keep for the Area. Tom reminds subcommittees that they are required to submit quarterly budgets next month (June). Tom is asking for ASC permission to create the ad-hoc. Stephen seconds the motion.

Jolene asks for more info. Tom explains that we are going back two years to track expenses so we know how much to keep in the Area account to cover expenses. Lyman reminds us that in the past, the Area has sent too much to Region and then we end up short as an Area. The hope is to have this ad-hoc committee's goal accomplished before RBS funds are divided up this year.

There are no objections to creating the ad-hoc committee for the budget. Tom invites any interested member to participate in the budget ad-hoc committee which meets on Sunday evenings at his house.

Paul proposes an ad-hoc committee to remind GSRs about ASC and/or act as liaison to groups. Megan indicates that per policy, facilitator and co-facilitator are designated as liaisons between ASC and groups. Megan educates Lyman on utilizing email address gsr@cbana.org as a way to reach all GSRs. He is willing to take on the responsibility of reminding GSRs about the ASC meeting prior to the ASC meeting.

During group reports, Megan asks Seanette if the New Beginnings group (Wed/Fri 7pm) is meeting. She states the person who was there last week did not even know the name of the group. The person who was involved in starting the meeting is unavailable for an indefinite period of time. Tom suggests that outreach attend the meeting, Seanette says they have been out there. She says the Monday meeting (No Matter What group) is going strong, but the Thursday meeting has been discontinued. Paul says what we have done in the past is to make a flyer for the group that is struggling and provide helpline info to community agencies.
