# **ACTIVITES:** Jolene

Put together a projected cost for the next two months, which include two upcoming events. One is the 4<sup>th</sup> of July event with H&I where we will help with food for the event. The other is a recovery bingo day with a back-to-school supply drive element. We will meet again in the coming weeks to finalize after the bingo suggestion goes back to the home groups. Itemized Monthly Expenses – For the 4<sup>th</sup> of July event, we plan on providing hot dogs, hamburgers, drinks and chips as well as having a concession stand. For recovery bingo, recovery bingo will be a \$5 donation. Prizes will be literature and school supplies. We will also need food and a venue.

Section V (Financial Provisions), heading B (Area Budgets), item number one has been updated. The activities subcommittee has been removed from the list of self-supporting subcommittees. This proposal passed in April but was just updated in policy in May due to policy chair's oversight.

This formatting edit does not change any content within policy. I also added a CBANA turtle to the first page purely for style. # **RECOVERY BY THE SEA: Stephen S.**

Remaining expenses are \$1300 for tent. One more merchandise order for shirts, two banners . . . u-haul, DJ and ASL interpreter will be paid at the event or after the event. Still working on moving Paypal to Zelle app. Concerned about auction items, have lost a couple items that we generally have available. We are brainstorming ways to come up with some items.

Paid insurance, bag order and items to go in bag are paid for, pre-registration shirt orders all paid for. Made \$360.00 from ESF on Saturday, June 25<sup>th</sup>, 2022. Hospitality earmark total is now \$1,071.28 for food expenses only. Pre-registration artwork is voted on . . .

Itemized monthly expenses – In bank account \$6,526.63. \$520 turned in cash from merchandise and \$269 for hospitality. Total available is \$7,046.63 minus \$802.28. \$6,244.35 was available to spend on insurance, pre-registration item/shirts. \$2,531.51 spent on bags so far.

Stephen asks for auction/raffle items to be donated if possible and encourages people to register for event so final expenses can be paid out.

#### LITERATURE: Lidilla R.

People are asking for literature during the month. Not all groups are attending Area or sending any one from groups to get literature or for reports. This needs to be resolved. Lidilla expresses concern that incoming literature chair will not be able to meet people at the clubhouse outside of ASC meetings to fulfill literature orders and asks if there needs to be a policy change. After some discussion, it is concluded that no policy change is needed; the literature chair is not required to be available for literature orders outside of the monthly ASC meetings. Lidilla asks everyone in attendance to spread the word that if literature is needed, it will only be available during ASC meetings. She also reminds us that book prices & medallion prices are going up in January per NAWS.

Accomplishments/Goals: Bringing literature stock back up and returning to self-supporting.

Itemized monthly expenses – Bank balance is \$1,554.96. Check to NAWS for \$926.84 leaving bank balance at \$628.12. PI owes \$255 from 5/15/22.

## CBANA Ad-Hoc: Tom M.

Dear CBANA family ad-hoc has formed and created a spreadsheet to keep track of monthly, quarterly, and yearly expenses with that we are finding policy changes that need to be made listed below. We have made budget forms to help subcommittees to present a budget for upcoming expenses.

Accomplishments/Goals – Add "toner and paper" to admin budget instead of "copies." Phoneline is a subcommittee, but will be paid with other admin expenses. Move annual treasurer report to December. To pay all admin fees in October. Add exception to recurring expenses to say auto-drafts are allowed where auto-drafts are required to sustain services (i.e. phone lines). Add to treasurer's duties including maintaining monthly spreadsheets to reflect incoming and outgoing money.

**OLD BUSINESS:** While establishing quorum, it is noted that not many GSRs are present today. Paul suggests forming an ad-hoc committee for someone to reach out to groups to remind them of ASC. Megan adds that she has gathered email addresses for GSRs for each group so they can at least receive the minutes. Paul's idea for ad-hoc is moved to new business. Lidilla proposes removing groups from the meeting schedule if they don't show up to Area. Tom indicates that policy can't be changed until July. Proposal to remove groups from the schedule if they don't attend Area will be tabled until July.

Tom M. proposes to create an ad-hoc for budgets and timelines for all committees. In that budget/timeline, a spreadsheet will be created that shows when ASC pays for what and when it is paid. The objective is to find out how much each subcommittee spends on quarterly expenses so we know what to set aside every year to keep for the Area. Tom reminds subcommittees that they are required to submit quarterly budgets next month (June). Tom is asking for ASC permission to create the ad-hoc. Stephen seconds the motion.

Jolene asks for more info. Tom explains that we are going back two years to track expenses so we know how much to keep in the Area account to cover expenses. Lyman reminds us that in the past, the Area has sent too much to Region and then we end up short as an Area. The hope is to have this ad-hoc committee's goal accomplished before RBS funds are divided up this year. There are no objections to creating the ad-hoc committee for the budget. Tom invites any interested member to participate in the budget ad-hoc committee which meets on Sunday evenings at his house.

Paul proposes an ad-hoc committee to remind GSRs about ASC and/or act as liaison to groups. Megan indicates that per policy, facilitator and co-facilitator are designated as liaisons between ASC and groups. Megan educates Lyman on utilizing

email address gsr@cbana.org as a way to reach all GSRs. He is willing to take on the responsibility of reminding GSRs about the ASC meeting prior to the ASC meeting.

During group reports, Megan asks Seanette if the New Beginnings group (Wed/Fri 7pm) is meeting. She states the person who was there last week did not even know the name of the group. The person who was involved in starting the meeting is unavailable for an indefinite period of time. Tom suggests that outreach attend the meeting, Seanette says they have been out there. She says the Monday meeting (No Matter What group) is going strong, but the Thursday meeting has been discontinued. Paul says what we have done in the past is to make a flyer for the group that is struggling and provide helpline info to community agencies. Stephen suggests sending a trusted servant to the meeting to offer to guide them the NA way. Lyman would be able to attend on Wednesday. Megan & Stephen are willing to attend a Friday meeting. Ryan also volunteers to attend.

NEW BUSINESS: Subcommittee quarterly budgets approved H&I-\$800. Activities-\$680. PR/PI-\$600. Outreach-\$450.

Outreach's request for reimbursement for March expenses without a receipt is approved. PI/PR's proposal for bus placards is tabled until current quotes/estimates can be obtained regarding the cost.

Discussion regarding New Beginnings group: Lyman attended on a Wednesday night. Stephen, Jolene and Megan attended on a Friday night. All agree that the meeting should remain on the schedule and that the chairperson is doing the best he can. All agree that the meeting needs support. Paul asks if they need a literature rack & IPs. Megan says the group did not ask for anything, but that it's probably a good idea.

Discussion regarding recorder & phone line chair—both service positions have not been present at ASC for two consecutive months (including June ASC), so the positions are going to be available for someone to step up and fill. Megan reached out to phone line chair to see if he plans to continue this position, but has not heard back from him.

Tom brings up policy changes for GSRs to take back to group related to the budget ad-hoc committee. These ideas will be brought up as proposals during July ASC and voted on.

- Add "toner and paper" to admin budget instead of "copies"
- Phone line is a subcommittee, but will be paid along with other admin expenses
- Move annual treasurer report in December
- To pay all admin fees in October
- Add exception to "recurring expenses shall be paid by check" to say "auto-drafts are allowed for instances where auto-drafts are required to sustain the service" (i.e. phone line)
- Add to treasurer's duties: maintain monthly spreadsheet to reflect incoming & outgoing money
- Propose quarterly budget form & unbudgeted item form
