SECRETARY REPORT: Last month’s minutes accepted.

RCM1: Region has not met again since the last ASC meeting, so there is nothing new to report. The next regional meeting will be in February and it will be hybrid. CBANA is hosting the regional meeting in May, which will also be hybrid.

RCM2: Don defers to Tom.

H&I: Subcommittee meeting was held today. The facilities are doing well. SATF needs women to carry the message, must be approved by the facility. We need a chairperson for Saturday detox meetings at Cenikor on the women’s side. The next event will be February 5 “For The Love of Service.” H&I subcommittee is planning to attend regional meeting 2/12/21. We are collecting books for the book drive. We have a possible new commitment for one of the units at the prison in Beeville. Jerrie asks if unit is co-ed, Troy clarifies it’s males only. Jerrie asks if women can participate on the H&I panel. Richard says he will find out more details.

PHONE LINE: no show/no report

ACTIVITES: Jerrie has given receipts to Richard for last month. She is requesting a check for \$600 for Christmas & New Year’s Eve functions and \$300 for a karaoke machine. The theme of the NYE dance will be prom. Vinny asks if the karaoke machine can double as a PA system. Karaoke machine will be discussed in new business. Stephen asks for clarification on amount being requested for upcoming functions. Jerrie clarifies the money is for decorations, rent, and food. Jerrie says she is looking into a venue other than the clubhouse for NYE dance. Tom says TBRCNA wants this area’s permission to collect registrations and sell merchandise at Christmas event. No one opposes this. The body votes to provide activities with \$600 for Christmas & NYE events.

Karah asks that outreach calendar to continue to be posted at clubhouse, Matt agrees to post calendar. Don asks if Beeville meeting can be added to rotation. Aharon says schedule is changing next month. Megan asks for group report to be emailed to her so she can update the schedule. Aharon agrees to provide information.

I have reached out to several facilities and checked in regarding their need of informational pamphlets and meeting list schedules. Of the facilities that I contacted, several requested more IPs and meeting list schedules. Those facilities include; parole, probation office on Gollihar Rd,

Cenikor, MHID, and STSARS. I requested and was approved time off from work first Monday of January so that I can deliver to the facilities. RECOVERY BY THE SEA: There is \$6640 in the account, last month \$2000 was spent in merchandise including towels. Already sold \$1500 worth, just need to sell \$500 more. Artwork was voted on and will be put on shirts, registration forms and banner. Subcommittee voted to use the same sound guy at last year for music & speaker tapes. He charges \$400 and RBS would collect 20% in royalties from speaker tapes. There will be a longer tent this year along with more chairs with a cost of \$3400 that was approved by the subcommittee today. Shirts will be \$25, pre-registration price won't change. Navy Army charges 3.9% for card swipes in addition to a monthly fee. It was agreed upon to keep using PayPal. Tom adds that a lot of research has been done on the best way to accept electronic payments and PayPal is the best option.

Don points out that speakers usually get a copy of their speaker tape at no cost. Troy says it's customary to get three bids for services such as sound instead of automatically using the same person as last year.

LITERATURE: Good afternoon CBANA. Happy holidays and greetings! Currently our literature bank account stands at \$1797.80 with a savings balance of \$100. Currently I have \$321 in cash and a check for \$59 from CBANA that I will deposit tomorrow during business hours. A literature order was placed today for more books and other items needed for stock. Please note that the pamphlets are still sitting are a valuable asset to other people who are in need of a tangible message. Also I am available in the evenings if anyone needs literature. A side note: the copier is completely out of toner and this needs to be replenished. Please help me get this addressed so we can continue to print schedules and other things necessary to carry our message. Thank you!

TREASURER: This is the first report from our new account and the bank statement is not current to all deposits/ withdrawals yet but by next month everything will be on paper to be reported in black and white.. So the charter bank has been closed from all accounts so we are officially moved over to the new bank for all area involved accounts.. I have \$3876.73 to be deposited from the old account and \$323.76 was deposited from last months area donations. I will sent a breakdown in this report of that deposit. We have stuff that we are waiting to clear on paper also.. \$1949.20 that is also be broken down in this report. This is all I have so far and I'll be available next month to help the new treasurer with reports till they are comfortable taking over. Thank you for letting me be of service . Richard T

Don asks for clarification regarding donation from RBS. Richard says we are currently \$1000 over prudent, but we need to wait until after new business to get a more accurate idea of how much money we have.

OLD BUSINESS: Nora is asking for \$400 quarterly budget for PR/PI. Joseph N. suggests allotting part of PR/PI budget for PI learning day. Bill suggests voting on budget next month in accordance with CBANA policy & procedure. Subcommittee budgets are tabled until next month. Troy W. introduces Joseph N. as the nomination for regional PR chair. Joseph asks ASC for support for when he attends the regional meeting in February. No voting is required by the ASC because the voting for this position will take place at the regional level. ASC gives support to Joseph. Karah nominates Nora for PI/PR chair, Nora qualifies herself and is voted in. Joseph N. nominates Vinny for RCM-1, but he declines the nomination. Megan nominates Bill. Bill qualifies himself and is voted in. Richard nominates Tiffany for H&I chair. Tiffany qualifies herself and is voted in. Karah nominates Alex N. for phoneline chair. Bill provides additional info on the requirements and David suggests we get Alex together with Don to get some knowledge about how the phoneline works. Alex qualifies himself and is voted in. Please note, by the time the position takes effect, Alex will have the required amount of clean time. Karah nominates Matt for outreach chair. Matt qualifies himself and is voted in. Karah nominates Megan for policy chair. Megan qualifies herself and is voted in. Stephen reports that Lidilla wants to be nominated for literature chair, but had to leave early today. The ASC still needs co-facilitator, co-literature, activities chair and treasurer. Please note the newly elected positions above will begin their terms in January 2022.

NEW BUSINESS: Lidilla nominates Carol for literature co-chair. Carol qualifies herself and is voted in. For purposes of getting added to the literature bank account, the minutes contain her full name: Carol Loupe. Stephen nominates Jerrie for activities chair. Jerrie qualifies herself and is voted in. Tom nominates Julia for recorder/secretary. Julia qualifies herself. Senior adds that she is the best. Julia is voted in.

Jerrie asks for \$300 for karaoke machine, she has found one to purchase. Stephen asks how we would decide who can use it because it would belong to the Area, not just the activities subcommittee. Don says it would be locked at the clubhouse and asks if it would have a warranty. Shelley voices a concern that there could be conflicts of interest if more than one group or subcommittee wants to use it at the same time, who would get preference? Tom suggests a sign-in/sign-out sheet. Stephen suggests that ASC would vote on use of the machine during the ASC meeting. Tom points out that this area doesn't have overlapping events, so there wouldn't be any scheduling conflicts. Jerrie asks who would purchase the machine since it will belong to Area and Troy says activities would make the purchase. Lidilla asks if a group uses the machine, would the GSR be responsible for it and Troy says yes. Aharon wants to take the vote on the karaoke machine back to his group. Proposal is tabled. Don indicates that GSRs are entrusted to make decisions. Aharon withdraws his request to discuss with his group. The motion for karaoke machine passes.

Outreach is requesting \$150 per month for gas and wants to be able to use the money for more than one vehicle. Tom points out that in the past, there have been problems with filling up multiple cars and it has gotten out of hand. Richard says ASC should pay for gas because it encourages more people to go. Megan asks if local meetings are included in the gas budget and Matt says it's only for meetings outside Corpus Christi city limits. Rodney points out that the cost to fill up a tank varies depending on the type of vehicle. Stephen suggests it needs to be a flat rate. Tom says four trips per month outside of city limits with two cars wouldn't add up to \$150. Megan suggests a set rate per mile and asks if the meetings that outreach has been visiting are in need of support. David suggests that this conversation needs to be rolled into the budget discussion. Troy says we need to trust the trusted servant. Vinny suggests that there needs to be an inventory of which meetings need support from outreach subcommittee.

Megan makes a motion to remove the meeting that occurs at Broken Chains from the schedule. Lidilla points out that this group has never attended ASC meetings. Troy reminds us that groups who do not attend ASC meetings can stay on the schedule. Senior points out that in his experience, the meetings at Broken Chains are not NA meetings. Matt agrees that they do not follow an NA format. Tom seconds the motion to remove this meeting from the schedule. There was no opposition and the motion passes.

Shelley proposes that ASC meetings return to being held in-person rather than hybrid. Senior asks if there are any groups outside of Corpus Christi who benefit from attending ASC via Zoom. Don points out that the Zoom option did not start due to Covid, but was started in order to include outlying groups such as Beeville and Victoria. Aharon suggests an amendment to the

proposal to rotate ASC location. Richard points out that we just paid rent to CBRC for the entire upcoming year for ASC. Lidilla reminds us that the literature bank is at the clubhouse and Tom says it would be too difficult for Lidilla to travel with literature. Shelley amends the proposal to say that ASC administrative officers are required to attend the meeting in person. Troy points out that this would require a policy change. Stephen adds that we could vote on paying for gas for outlying groups to attend ASC meetings. Lidilla says that paying for gas to attend the ASC meeting is a home-group issue. Don reminds us that Area is here to support groups and ASC should pay for gas for GSRs to attend the meeting. The proposal to require officers to attend in-person has been tabled. GSRs will need to take this back to their groups: should ASC meetings be held only in person or keep the hybrid format/option?

Budgets: Outreach is requesting \$150 per month (\$450/quarter), budget passes. RCM 1&2: \$250/quarter for gas & hotel, budget passes. Phoneline: \$150/quarter, budget passes. Web servant: \$100/quarter, budget passes. PI/PR: \$600/quarter, budget passes. H&I: \$600/quarter, budget passes. Activities budget is an active & variable flow–no budget set at this time. The ASC will need to review budgets in three months.
